2. Anyone intoxicated prior to the departure of the ski/snowboard trip will be excluded
3. Any drunken disorderly conduct will not be permitted and will result in the notification to the parent(s). Individuals will be sent home immediately at the parent(s) cost.
4. Anyone experiencing illness resulting from intoxication on the bus or in the hotel rooms will be penalized with a \$300.00 surcharge, payable immediately. Cleanup is also the responsibility of the individual.
5. Parental Waivers with this letter must be signed and submitted to our office prior to the departure of the ski/snowboard trip.
6. No one is permitted on the tour without a signed parental consent form.
7. Telephone calls will be made at random to verify that the parent/guardian have actually signed these documents.
